

## PREVAILING WAGE RESOLUTION

WHEREAS, the State of Illinois has heretofore adopted "An Act regulating wages of laborers, mechanics and other workers employed in any public works by the State, county, city or any public body or any political subdivision or by anyone under contract for public works," approved June 26, 1941, as amended (the Prevailing Wage Act), being 815 ILCS 130/0.01 *et seq.*; and

WHEREAS, the aforesaid Act requires that the Board of Education of Marquardt School District No. 15, DuPage County, investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics and other workers in the locality of Marquardt School District No. 15 employed in performing construction of public works for Marquardt School District No. 15.

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED BY THE BOARD OF EDUCATION OF MARQUARDT SCHOOL DISTRICT NO. 15, DUPAGE COUNTY, as follows:

Section 1: To the extent and as required by the Prevailing Wage Acts of laborers, mechanics and other workers employed in any public works by the State, county, city or any public body or any political subdivision or by anyone under contract for public works, as amended, the general prevailing rate of wages in the locality of Marquardt School District No. 15 is hereby ascertained to be the same as the prevailing rate of wages for construction work in DuPage County, Illinois, as determined by the Department of Labor of the State of Illinois as of September 1, 2017, a copy of that determination being attached hereto as Exhibit A and incorporated herein by reference. The definitions of any terms appearing in this Resolution which are also used in the aforesaid Act shall be the same as in said Act.

Section 2: The general prevailing rate of wages in the locality of Marquardt School District No. 15, and the general prevailing rate for legal holidays and overtime work, as specified herein,

shall be paid for each craft or type of worker needed to execute any contracts for public work or perform work relating to such contracts which are let by the School District. This Resolution is incorporated by reference in each such contract, effective September 1, 2017.


Section 3: Nothing herein contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works construction of Marquardt School District No. 15 to the extent required by the aforesaid Act.

Section 4: The Superintendent is hereby directed to publicly post or keep available for inspection by any interested party in the Business Office of the School District this determination of prevailing rates of wages and to promptly file a certified copy of this Resolution with the Illinois Secretary of State and the Illinois Department of Labor.


Section 5: Within 30 days after filing with the Illinois Secretary of State, the Superintendent shall also cause to be published in a newspaper of general circulation within Marquardt School District No. 15 a notice of this determination, substantially in the form of Exhibit B attached hereto, and shall promptly mail a copy of its determination to any employer and to any association of employers and to any person or association of employees who have filed their names and addresses, requesting copies of such determination.
